

Disclosure of Supervised Providers

KFIA, pursuant to Hague Standard 96.39 a(2), is required to disclose any domestic (in the United States) or foreign supervised providers that we use in conjunction with any Hague convention countries that you can be expected to work with as well as the usual costs associated with their services. **KFIA does not work with any supervised providers for the provision of services within the United States.** The Foreign Supervised Providers we work with and the approximate costs of their services (as also set forth in our information packet) is as follows:
